Terms of References

For procurement of Training of grant beneficiaries from the Ministry of Agriculture Forestry Rural Development (MAFRD):

“Improving the Livelihood and Strengthening the Position of Dairy Farmers in Rural Areas”

I. Background

We Effect is a Swedish development organisation present in Africa, Asia, Europe, and Latin America. Our work focuses on reducing poverty and inequality by strengthening the ability of member organizations to enable women and men, girls and boys living in poverty to improve their living conditions, defend their rights and contribute to a just society. The work is focused to the following areas: rural development, housing, gender equality, environment and financial inclusion. In Europe, We Effect is present in Albania, Bosnia and Herzegovina, Kosovo¹, Moldova, and North Macedonia.

Target groups of We Effect’s development cooperation are We Effect’s partner organizations (civil society organizations), mostly represented by member-based organizations active in rural development, farmers’ associations, producers’ groups, and cooperatives. We Effect applies a rights-based approach where development interventions are the results of the dialogue with our partner organizations, with strong local ownership, characterized by accountability, transparency, non-discrimination, and meaningful participation.

The We Effect Regional Office Europe makes significant efforts in applying sustainable and results-oriented practices by combining environmental, social, and economic development perspectives in one integrated development framework. In that sense, specific topics of environment and economic development were selected to drive the new program 2023-2027. In terms of social and economic development perspectives, the focus is placed to strongly empowering partner organisations for delivering improved services to their beneficiaries, predominantly represented by farmers (agriculture practitioners).

For this purpose, KAMP staff which are involved in the project, supported from MAFRD representatives will organize and train farmers on procedures for implementing grant and preparing feed and Balancing rations and Dairy farm management and housing

The main purpose of this activity is to train grant beneficiaries who receive grants from MAFRD. The purpose of the training will be to increase technical knowledge in farm management and increase productivity in livestock farms. Three groups of farmers will be

created and each group will be trained in four training topics. In total 100 grant beneficiaries will be trained.

II. Objective of the assignment

Under Result 1: Strengthening of Civil Society Organisations/Stronger Organisations, Number of new services developed to address the needs of the members (right-holders) and/or generate income for KAMP. For this year was foreseen to have trainings for 100 grant beneficiaries on:

- Procurement procedures for grant implementation
- Monitoring and reporting
- Preparing feed (forage feed) and Balancing rations
- Dairy farm management and housing

KAMP staff and representatives of MAFRD will be responsible to organize and train farmers:

- a). Procurement procedures for grant implementation
- b). Monitoring and reporting
- c). Preparing feed (forage feed) and Balancing rations
- d). Dairy farm management and housing Duty travel & accommodation

Travel through Kosovo is foreseen in this assignment.

III. Coordination & Reporting

The coordination and organization of the training will be done by the KAMP staff who are engaged in the project. Two training topics will be held by KAMP staff (Preparing feed (forage feed) and Balancing rations and Dairy farm management and housing) and two training topics will be held by local experts (Procurement procedures for grant implementation and Monitoring and reporting).

Local experts will work under the direct supervision of the KAMP project manager. The KAMP staff will closely follow the progress of work under this assignment.

Local experts will be reporting directly to the KAMP project manager. The intended dynamics of the assignment is the following:

IV. Activities/Deliverables

The training will be organized during May – July 2024

V. Qualification requirements

KAMP staff has qualifications and experience for organizing those trainings.

Qualifications & skills for local experts

- ✓ A bachelor's degree in Agro-economic, Agricultural faculty or equivalent relevant experience;
- ✓ Proficiency in English, including effective spoken presentation and written reporting abilities;
- ✓ Computer literacy at the user's level.

General professional experience

- ✓ Have a minimum of 2 years of professional experience in providing services for non-governmental organizations.

Specific professional experience

- ✓ Ability to work flexibly and re-prioritize as necessary.
- ✓ Has excellent written and verbal communication skills and attention to detail
- ✓ Able to establish and build professional working relationships through strong interpersonal skills and the ability to work as part of a team.

Assets:

- ✓ Previous experience in Kosovo and knowledge of Serbian or Albanian will be a strong advantage.

Selected experts will be requested to communicate with KAMP for any unclear situation or challenge that they might face during the implementation of the tasks, especially the challenges in practising the above-mentioned competencies.

VI. Application procedure:

By May 24th, all interested experts should send their application to shpqkkamp@gmail.com, info@shpqk.org.

Email should include a **CV, Financial Offer, and Declaration of Relationship**.

By May 27th, the evaluation of offers is going to be conducted and signed.

By May 28th, the contract will be signed by both parties (local expert and KAMP official representative).

By May 28th, the consultant will start with the implementation of the contract.

The service provided will be replenished at the moment that the expert has submitted on time the agreed documentation for the realization of this service at the end of the contract.

Financial offer in EUR for the tasks specified in the Terms of Reference.

VII. Evaluation of the offers

The incomplete applications or applications received after the deadline for submission will not be taken into consideration.

The evaluation of offers will be based on the “best value for money principle” by using a weighted scoring method to evaluate the combination of the applicants’ qualifications (60%) and financial proposal (40%).

The award of the contract will be made to the bidder whose offer has been evaluated as:

- Responsive/compliant/acceptable, and
- Having received the highest combined score out of a weighted technical and financial evaluation specific to the solicitation

Technical evaluation (60%):

The technical evaluation of the received offers will consist of:

- Evaluation of education [max 10 points]
- Evaluation of overall professional experience [maximum 5 points]
- Basic knowledge in the use of MS Excel and English [maximum 5 points]
- Familiarity with the agriculture sector in Kosovo [maximum 30 points]
- Experience in rural development context [maximum 10 points].

Only the candidates who will reach the threshold of 60% (min 50 points out of maximum 60 points available for the technical evaluation) will be considered for the financial evaluation.

Financial evaluation (40%)

The financial offers are expected to be delivered in a separate email that will not be considered for evaluation before receiving the results of the technical evaluation.

Once the technical evaluation is finalized, the consultants that gain at least 50 points are going to be subject to financial evaluation.

The offers of the applicant that is being technically evaluated as not responsive (gained 50 or less points in technical evaluation) will not be subject to financial evaluation.

For those that will pass the minimum threshold (50 points and more), the evaluation of the financial offers will be conducted in the following manner:

- The offer with the lowest price shall receive a total of 10 points.
- The other offers with higher prices shall receive the respective score according to the following formula: $10 * (\text{Lowest Price} / \text{Proposed Price})$.

The final evaluation will be the sum of the points generated in the technical and financial evaluation. One applicant who gained the best score in the final evaluation will be offered a contract with KAMP for the implementation of the assignment. In case the best applicant/s is/are being prevented from signing the contract, KAMP will offer a contract to the applicant/a that gains the next (second/third/fourth) best score in the evaluation process.

Note: the maximum number of days for this assignment is 3 working days (two training days, and one day for preparing final report).

VIII. Terms of payment

- The payment will be done upon approval of the entire set of documents.

IX. Declaration of relationships

The Applicant shall describe if their organization/employees have any business or personal relationships with closely associated parties from We Effect, its Regional Office in Skopje, its governing bodies and employees.

A closely associated party (persons, physical or legal) as per We Effect's definition is considered a person who has the possibility to exert control over, or significant influence on, the other person when it comes to financial and operative decision-making concerning an activity. The purpose of the Declaration is to disclose such information which makes the application and evaluation process more transparent and supports the bids in its relevance according to conditions on the open market.
