For procurement – Shooting Videos (3-5 min) with practical instructions from the field under the project:

“Improving the Livelihood and Strengthening the Position of Dairy Farmers in Rural Areas”

I. Background

We Effect is a Swedish development organization present in Africa, Asia, Europe, and Latin America. Our work focuses on reducing poverty and inequality by strengthening the ability of member organizations to enable women and men, girls and boys living in poverty to improve their living conditions, defend their rights and contribute to a just society. The work is focused on the following areas: rural development, housing, gender equality, environment and financial inclusion. In Europe, We Effect is present in Albania, Bosnia and Herzegovina, Kosovo¹, Moldova, and North Macedonia.

Target groups of We Effect’s development cooperation are We Effect’s partner organizations (civil society organizations), mostly represented by member-based organizations active in rural development, farmers’ associations, producers’ groups, and cooperatives. We Effect applies a rights-based approach where development interventions are the results of the dialogue with our partner organizations, with strong local ownership, characterized by accountability, transparency, non-discrimination, and meaningful participation.

The main purpose of this activity is the shooting 5 videos (3-5 min) with practical instructions from the field. In the project live has been foreseen to developed 15 videos from the filed in different topics.

With this assignment will be prepared five videos. Five videos will be addressed this activity:

- Videos on good dairy farm management practices
- Videos on good milking hygiene practices
- Videos on good ventilation on dairy farm
- Videos on hoof treatment
- Videos on mastitis treatment

II. Objective of the assignment

Under Output 3.3: Informed small-scale dairy farmers and Activity 3.3.1: Shooting Videos (3-5 min) with practical instructions from the field.

The local company is asked to prepare and delivering five videos on topics:

- Videos on good dairy farm management practices
- Videos on good milking hygiene practices
- Videos on good ventilation, lighting on dairy farm
- Videos on hoof treatment
- Videos on mastitis treatment

Each video should contain understandable information for the farmer and should last 3 to 5 minutes. The video and sound quality must be clear and of high quality.

Video materials must be submitted on CD, which can be copied and published on the KAMP association's website.

III. Duty travel & accommodation

Travel through Kosovo is foreseen in this assignment. Videos will be taken on the filed around Kosovo selected by KAMP staff. All preparatory work with KAMP will be organized virtually.

IV. Coordination & reporting

Local company will work under the direct supervision of the KAMP project manager. The KAMP staff will closely follow the progress of work under this assignment.

V. Qualification requirements

General professional experience

- ✓ Have a minimum of 1 years of professional experience in shooting video and promotion in agricultural sector.

Specific professional experience

- ✓ Ability to work flexibly and re-prioritize as necessary.
- ✓ Has excellent written and verbal communication skills and attention to detail
- ✓ Able to establish and build professional working relationships through strong interpersonal skills and the ability to work as part of a team.

Assets:

- ✓ Previous experience in Kosovo and knowledge of Serbian or Albanian will be a strong advantage.

Selected company will be requested to communicate with KAMP for any unclear situation or challenge that they might face during the implementation of the tasks, especially the challenges in practising the above-mentioned competencies.

Financial offer in EUR for the tasks specified in the Terms of Reference.

VII. Evaluation of the offers

The incomplete applications or applications received after the submission deadline will not be considered.

The evaluation of offers will be based on the “best value for money principle” by using a weighted scoring method to evaluate the combination of the applicants’ qualifications (60%) and financial proposal (40%).

The award of the contract will be made to the bidder whose offer has been evaluated as:

- Responsive/compliant/acceptable, and
- Having received the highest combined score out of a weighted technical and financial evaluation specific to the solicitation

Technical evaluation (60%):

The technical evaluation of the received offers will consist of:

- Evaluation of education [max points]
- Evaluation of overall professional experience [maximum 25 points]
- Familiarity with the agriculture sector in Kosovo [maximum 20 points]
- Experience in rural development context [maximum 10 points].

Only the candidates who will reach the threshold of 60% (min 50 points out of maximum 60 points available for the technical evaluation) will be considered for the financial evaluation.

Financial evaluation (40%)

The financial offers are expected to be delivered in a separate email that will not be considered for evaluation before receiving the technical evaluation results.

Once the technical evaluation is finalized, the consultants that gain at least 50 points are going to be subject to financial assessment.

The offers of the applicant that is being technically evaluated as not responsive (gained 50 or less points in technical evaluation) will not be subject to financial evaluation.

For those that will pass the minimum threshold (50 points and more), the evaluation of the financial offers will be conducted in the following manner:

- The offer with the lowest price shall receive a total of 10 points.
- The other offers with higher prices shall receive the respective score according to the following formula: $10 * (\text{Lowest Price} / \text{Proposed Price})$.

The final evaluation will be the sum of the points generated in the technical and financial evaluation. One applicant that gained the best score in the final evaluation will be offered a contract with KAMP for the implementation of the assignment. In case the best applicant/s is/are being prevented to sign the contract, KAMP will offer a contract to the applicant/a that gains the next (second/third/fourth) best score in the evaluation process.

IX. Declaration of relationships

The Applicant shall describe if their organization/employees have any business or personal relationships with closely associated parties from We Effect, its Regional Office in Skopje, its governing bodies and employees.
