I. Background

We Effect is a Swedish development organisation present in Africa, Asia, Europe, and Latin America. Our work focuses on reducing poverty and inequality by strengthening the ability of member organizations to enable women and men, girls and boys living in poverty to improve their living conditions, defend their rights and contribute to a just society. The work is focused to the following areas: rural development, housing, gender equality, environment and financial inclusion. In Europe, We Effect is present in Albania, Bosnia and Herzegovina, Kosovo¹, Moldova, and North Macedonia.

Target groups of We Effect’s development cooperation are We Effect’s partner organizations (civil society organizations), mostly represented by member-based organizations active in rural development, farmers’ associations, producers’ groups, and cooperatives. We Effect applies a rights-based approach where development interventions are the results of the dialogue with our partner organizations, with strong local ownership, characterized by accountability, transparency, non-discrimination, and meaningful participation.

The We Effect Regional Office Europe makes significant efforts in applying sustainable and results-oriented practices by combining environmental, social, and economic development perspectives in one integrated development framework. In that sense, specific topics of environment and economic development were selected to drive the new program 2023-2027. In terms of social and economic development perspectives, the focus is placed to strongly empowering partner organisations for delivering improved services to their beneficiaries, predominantly represented by farmers (agriculture practitioners).

For this purpose, we are looking to engage a local expert for collecting data and monitoring farmers that apply for financial services and monitoring farmers applying for grant scheme and monitoring successful applications.

- Monitoring number of farmers applying for grant scheme and monitoring successful applications for grant scheme for 2024

II. Objective of the assignment

Under Result 3: Sustainable Livelihoods and Activity 3.1.2 and 3.2.2 the local expert is asked to:

- a). Monitoring farmers that apply for financial services and follow the successful loan application for dairy farmers
- b). Monitoring farmers applying for grant scheme and monitoring successful application for grant scheme

The expert needs to get information form intuitions; for grant application and successful applications need to get data from Ministry of Agricultural and Rural Development and for the financial services and successful loan application need to get data from financial intuitions.

The expert needs to show to KAMP in practice how KAMP can collect information about who applied and how many were successful for loan and grant applications for the future.

III. Duty travel & accommodation

Extensive travel is not foreseen for this assignment. All preparatory work with KAMP will be organized virtually. The all works foreseen in this assignment is desk research.

IV. Coordination & reporting

Local experts will work under the direct supervision of the KAMP project manager. The KAMP staff will closely follow the progress of work under this assignment.

V. Qualification requirements

Qualifications & skills



- ✓ A bachelor degree in agro-economics, agricultural faculty or equivalent relevant experience;
- ✓ Priority with master's degree in agro-economic, agricultural faculty, or equivalent relevant experience;

General professional experience

- ✓ Have a minimum of 1 year of professional experience in providing services for non-governmental organizations.

Specific professional experience

- ✓ Ability to work flexibly and re-prioritize as necessary.
- ✓ Able to establish and build professional working relationships through strong interpersonal skills and the ability to work as part of a team.

Selected experts will be requested to communicate with KAMP for any unclear situation or challenge that they might face during the implementation of the tasks, especially the challenges in practicing the above-mentioned competencies.

By November 05th, the evaluation of offers is going to be conducted and signed.

By November 06th, the contract will be signed by both parties (local expert and KAMP official representative).

By November 07th, the consultant will start with the implementation of the contract.

The service provided will be replenished at the moment that the expert has submitted on time the agreed documentation for the realization of this service at the end of the contract.

Financial offer in EUR for the tasks specified in the Terms of Reference.

VII. Evaluation of the offers

The incomplete applications or applications received after the deadline for submission will not be taken into consideration.

The evaluation of offers will be based on the "best value for money principle" by using a weighted scoring method to evaluate the combination of the applicants' qualifications (60%) and financial proposal (40%).



The award of the contract will be made to the bidder whose offer has been evaluated as:

- Responsive/compliant/acceptable, and
- Having received the highest combined score out of a weighted technical and financial evaluation specific to the solicitation

Technical evaluation (60%):

The technical evaluation of the received offers will consist of:

- **Evaluation of education [max 20%]**
 - Bachelor's degree in Agricultural or agri-economic sciences 10%
 - Master's degree in Agricultural or agri-economic sciences 15%
 - PhD degree in Agricultural or agri-economic sciences 20%

Note: if the consultant has no education in the related field but has more than 8 years of experience in similar economic fields she/he will be granted zero points in this component, but will not be eliminated for not meeting the minimum requirements and will continue being evaluated against other evaluation criteria.

- **Evaluation of overall professional experience [maximum 30%]**
 - Minimum 3 years 10%
 - 6-7 years 20%
 - 8 years and more 30%
- **Experience in preparing research reports [maximum 10 %]**
 - Minimum 1 report 3%
 - 2-3 reports 5%
 - 4 or more reports 10%

Only the candidates who will reach the threshold of 60% of the technical qualification will be considered for the financial evaluation.

Financial evaluation (40%)

Based on the formula: $40 * (\text{Lowest Price} / \text{Proposed Price})$.

VIII. Terms of payment

IX. Declaration of relationships
